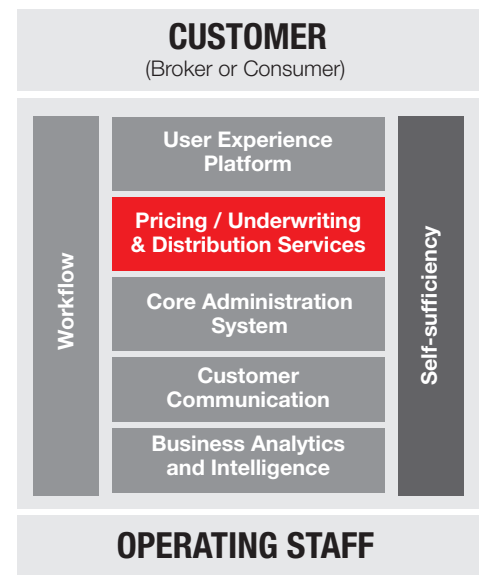

	SSP Rates Builder	Executes a run-time environment that uses familiar spreadsheet-based technologies to define a product.
	Underwriting	A specialised instance of the SSP Precision Engine Module designed to apply underwriting rules (e.g. to apply acceptance criteria prior to core rating taking place).
PRICING	Tactical pricing*	A specialised instance of SSP Precision Engine Module designed to apply sophisticated pricing rules (e.g. to perform price optimisation after core rating has concluded).
	Third party price optimisation	Integration to third party optimisation technology such as Towers Watson Radar Live Price Optimiser, or another of your choice.
RULES	SSP Precision Engine*	Sophisticated, high-performing Rules Engine to provide ultimate flexibility and business agility.
	Capping and Collaring	The application of value thresholds to premiums generated by quotation engines.
	Eligibility rules	Validate against eligibility criteria to deliver the right products to the right market segment.
	Post underwriting rules	The technical rate is divorced from the post underwriting rules providing the ability to react, flex and change quickly without the need to change technical rating.
